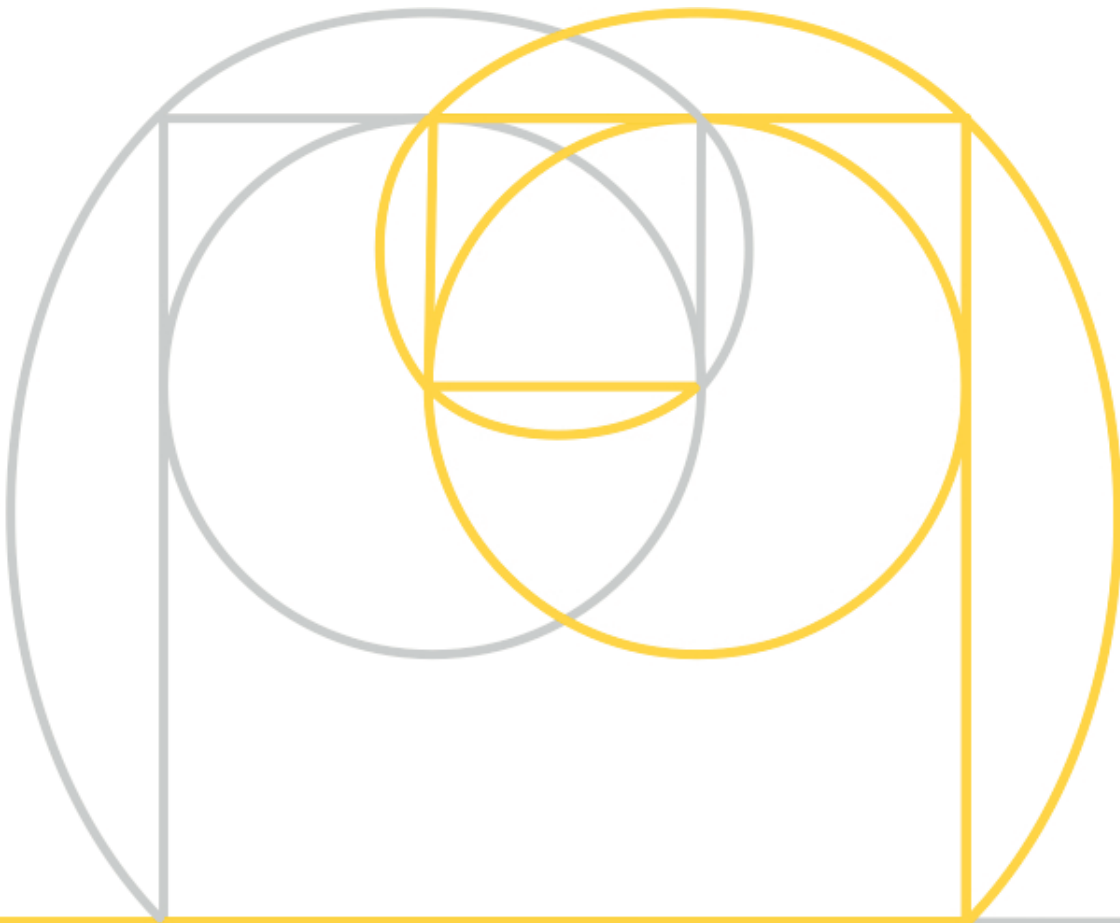


Getting Out of a Stagnant Economy: Purifying The California Community Property Law

Executive Summary

California's economy, if it were a sovereign nation, would rank the fourth largest in the world, but because of circumstances based on its community property laws for divorces, which are running rampant, California's economy is becoming stagnant. There is still an enormous flow in the state, but due to the upcoming financial crisis on a global basis, it is facing a severe financial crisis.

At the present time, California's economy looks like it is booming, but various issues are causing problems, which we will not address in this proposal because they will play out ripple by ripple. California, through this proposal, will establish an opportunity to introduce the principles of the global renaissance from this segment. There will be seven different aspects that we will address related to the global renaissance, and this is the first. We are turning around California's stagnant economy as a demonstration to the United States for how to get out of a stagnant economy.

Let's say that there are seven games that are played. Seven power games that are played, and their ultimate conclusion is to back an individual or a nation, whatever entity it may be, into a proverbial corner. In this proposal we will address one of the seven games. The games have to do with the Seven Deadly Sins, and this relates to the game of Lust. It is not based on loose living and debauchery, which is the logical, common interpretation of the word *lust*. It involves binding someone to you. When it is played on a societal level, in its extreme form, it leads to the issue of slavery. We will address the issue related to California, and the game that is being played, and this will demonstrate how to come away from a situation where you have no cash flow.

At the present time, many marriages are breaking apart. The global economic situation is that China and Japan—other nations—are attempting to rise up, understanding that this is their century to shine. The Asians have taken the power games to an elite level. They are playing the games introduced by the United States over the last century, and taken the games to their ultimate conclusion. The problem with this is that each culture and each religion has a favorite game it plays. Asian countries, under Confucianism, have the tendency to address the issue of capacity, and the games that are played, like sweat shops, where people work for basically slave labor, is a demonstration of this practice. In China or Japan, any that rely on sweat shops for low pay, this is basically a demonstration of slavery, where people cannot rise out of their financial crisis. The people in power in the sweat shops basically own the people who work for them. Should the Asian influence and power structure continue to expand, it will continue to be instated as the global economy.

I will segue for a moment to explain that with the international government that is being established at the present time, mankind is making choices. The first choice is to continue on with the power games, which will slowly erode, like the Asian countries taking the games to their ultimate conclusion. This will create a sweat shop environment across the planet. This statement is not a judgment, but a mentality that will be allowed to

progress by allowing certain laws to be created on an international level, where the United States or other countries will not be able to stand up to protest. Those countries will be backed into the corner and people will become unempowered to rise up against the major corporations that are taking over. An example of this is on the Internet; a law has been established that your domain name can be sold to another individual or corporation, and that entity can exploit your domain name. Another example is someone purchasing your genes, so technically speaking, they own your genetic structure, and the ultimate conclusion of that is that you are not able to function with your genetic code. You become... and this is the idea of the prophecy in the Bible of the 666, or Big Brother from the book, "1984," where others can own you.

The second choice mankind has is to go down into creating a sense of illusion, and that also has the sense of slavery, where people are backed into the proverbial corner. The first choice involves the power games, and the second has to do with, not just owning what you produce, but owning your life. It is the difference between a virtual slave and an actual slave. This would be like a genocide, where the other owns your life, and has the right to destroy you. This is where the pogroms came about, or the ethnic cleansing. "We have the right to destroy you, to kill you." No one can stop it because no one understands how to come out of the game. This choice has to do with the conspiracy international government concept, where people turn you into actual slaves, and there have been rumors of concentration camps that have been set up, and some people believe they have the right to put you into them. An example of this would be the Soviet Union, where political dissent occurred and people were sent to Siberia and never heard from again. There is no way out of the crisis.

The final choice that mankind has is to function on a higher level, and that is where we are going to address in this proposal.

The actions that are the results of the issue of slavery, that we are addressing now, deals with the idea of binding someone to you. An example of this, in a very innocuous form, is the idea of the "trophy wife." This appears to be an innocuous concept, but in truth, it is creating havoc in the state of California because many people, like during the "dot com boom," or in the Silicon Valley, quickly created a great deal of wealth. Imagine that women— trophy wives—became a status symbol. These women rely for their capacity on their appearance, but they may play a game to entrap the man. It appears to be a win-win agreement, but to carry the idea to the ultimate conclusion...

To clarify this, there have been many divorces that are not based on appearance, but this allows us to demonstrate the concept of slavery and how the game can backlash on you...

Imagine this woman relies for her capacity on her appearance, and she finds a wealthy man who considers a beautiful woman on his arm to be a status symbol. At some point in time, she comes to the understanding that she is developing wrinkles, or someone more attractive is moving in on him and there is a sense of infidelity, then whether or not the issue is true, her fears can trigger their divorce. There are many divorces right now. It appears she is coming out with half of their business, but if the business has been sold

because if he cannot buy her out...

The economy is worsening from the war in Iraq, and the Asian countries and other foreign countries are purchasing the companies. It is not a matter of alimony, it is that she gets half, but there is no business. There is cash to purchase luxury items but there is no cash flow. This is the ultimate conclusion of the California community property laws. It is that there is a great deal of wealth, but at some point in time, there is no flow. There is a huge influx of cash, but no firm foundation to make it stable and to keep a flow. For a long time California has functioned this way.

Our proposal, therefore, is to introduce certain principles about this. Our proposal carries the idea forward to offer a solution, and we will demonstrate this shortly within our organization as it comes about. We will demonstrate this to the federal government, but prior to that, to prevent the stagnation of our economy, we will demonstrate it in California to shore up the crumbling U.S. economy.

The first principle to address has to do with the concept of win-win agreements. Marriages will be based on this concept especially where there is a great deal of wealth involved, but marriages in general will be based on this concept. It is a win-win agreement with a common goal. At the present time, there are no common goals with the marriage to a trophy wife, so this will be instated first with a marriage that is coming about, but as the marriages fall apart, and the businesses are being sold, instead of selling them to Asian countries, we will instate into the California economy amongst 100 or so millionaires who have had this marriage crisis—whether impending, in the process, or are attempting to recover from the crisis of a divorce—we are going to introduce our fifty projects to these individuals, and they can invest in them.

The principle behind it is that they are, first, investing in the projects but they do not own the projects. Therefore, there is no way these projects will be turned over to a wife. We have what we call a “lifepartnership agreement,” and that will be discussed amongst families to allow everyone to understand that each must function within his or her own capacity, that there is no way, should a divorce occur, that they will be able to draw on the funds from the fifty projects. The established framework of the existing businesses is another issue, and that remains under existing California law. But, as the business owners invest in the projects, they will not be able to own the projects. The projects will remain as part of the network, and the investors will be able to draw on the profits, but they will not own the business. It remains part of the framework, and this is part of our non-profit agreement, which will be addressed in a proposal to Congress, and related to 501 (c) 3 non-profit organizations.

All of the different aspects will be addressed in various proposals we will introduce, including purifying the U.S. legal system to enable the rights of the framework to be established.

To go forward, once this lifepartnership is addressed within the family, at that point that segment of the investments will be put into an account that cannot be touched by the family, but at the same time, the benefits from the projects will flow back to the family to ensure that nothing is being taken from the family, that the family will be

allowed to function on a higher level than what exists now, so there won't be any fears. This, as I said, will be addressed in other proposals.

The final thing in this aspect will be to address the issues of inheritances, family issues related to legalities, and several other issues, which, as I said, will be addressed in the lifepartnership aspect.

As the global renaissance comes about, as we address in "The Principles of the Global Renaissance," each individual must function from within his or her own capacity, and within the international government, through our church segment, we will teach how to create this life on a higher level. This will function on a national level, and an international level, and the rights to do so will be guaranteed by the international government. This is looking at it from the perspective from the individual level, and through the "Flower of Life" pattern. We will address the corporate aspect in another segment.

How this functions, then, is how the individuals who have the vast fortunes from the sales of the business but now have no cash flow will invest in the fifty projects, and then as they do so, the benefits will return to them, but multiplied. It will spin off technologies based on the same principles. The principles will be addressed in another proposal.

The global renaissance will establish a new framework for the businesses to function. Non-profits and for-profit businesses will all function within the same parameters. The taxation aspect will start to return to the government at that time, because issues on a national level, such as foreign aid, defense, social programs such as Medicare and health issue, will be addressed through this program, so the cost of government is about to go down dramatically. There won't be any need to draw such remarkable taxes, and so the IRS code will be addressed as we purify the US legal system. This we will do in another aspect, also.

Imagine that as the marriages break apart, and the 100 millionaires invest in the projects, and they create a sense of cash flow, then they will go on to establish a teaching program in a partnership with the individual who is responsible for creating the project. The sponsor and the inventor will teach the governments, and they will be a resource for the foreign governments and the US government to establish this global renaissance.

The final thing is that our churches will teach the people how to create their life on a higher level based on these principles, and the people who create the projects will be a resource to the international governments through a catalog of projects that will be available to the leaders, and the inventor/investor teams will go as "teachers to the teachers" in a country. This will be one of the incentives for joining the international government. At that point in time, the resources of the entire world, or of the nations that participate, you will be able to draw on, and we will be able to multiply them, which we will address in another project.

Along with this proposal will be a packet of information that relate to the issues that we have addressed.

So be it and so it is.
